6. Neena Dutta and she shall hold that office and position up to the time of her death, incapacity, insolvency, resignation or refusal to act as such.

7. That the first meeting of the Board of Trustees shall be held within three months of the date of execution of this Deed and shall be summoned by the Founder of the Trust by giving at least seven days notice in writing to all the Trustees to be held at such place and time as may be specified in the notice and in that meeting all relevant matters pertaining to the Trust shall be considered in all possible details and particularly the ways and the manners to give effect of to the provisions of the deed of Trust and to attain the object and purpose

The staff so employed shall be paid such salaries as the Trustees may decide according to the Rules prescribed by the School service Rule etc.

9. That the Board of Trustees shall keep proper books of accounts, which shall be closed on 31st day of March every year and after duly audited by qualified Auditor(s) appointed by the Trustees, shall be placed before the meeting to adopt the same.
